ACRA BASKETBALL TOURNAMENT, 2013
RULES & REGULATIONS

1. Only members (include Fellow, Corporate & Associate) of The Hong Kong Air Conditioning and Refrigeration Association Limited are eligible to join this competition and only amateur player would be accepted.
2. Twelve teams will be invited to compete for the overall championship. The teams will be divided into two groups competing for the highest points in their respective groups in the first round of matches. The teams with the highest and second highest points in each group will be eligible to complete in the final champion and 2nd runners up matches respectively.
3. Points will be allocated in each match as follows:
Win : 3 Points
Draw : 1 Point
Lose : 0 Point
4. All matches will follow the international basketball regulations, except that the duration of each half in the preliminary round matches will be 10 minutes instead of 20. The duration of each half in the final champion and 2nd runners up matches will remain unchanged as 20 minutes and each half will be separated into 2 periods of 10 minutes each.
5. All players must follow the rules/regulations of the Southorn Stadium.
6. All teams must report to the Committee 15 minutes before commencement of each match. The Committee will have the authority for final judgment of any disputes arisen.
7. The game fee shall be paid one week in advance of the game. The debit note would be issued by ACRA in due course.
